## I. INTERNATIONAL

### CSCE TO CONVENE JULY 30

JULY 14 (IPS)-- THE THIRD "SUMMIT " PHASE OF THE CONFERENCE ON SECURITY AND COOPERATION IN EUROPE (CSCE) WILL DEFINITELY CONVENE IN HELSINKI JULY 30, REPORTS EAST GERMAN RADIO THIS MORNING. THE SOVIET UNION AND ITS ALLIES OVERCAME LAST DITCH RESISTANCE FROM PRO U.S. AND MAOIST CONNECTED WESTERN EUROPEAN DELEGATIONS, TO PUSH THE SUMMIT DECISION THROUGH THE GENEVA MEETING OF THE CSCE COORDINATING COMMITTEE AND GAIN THE NECESSARY CONSENSUS. THE CSCE SUMMIT WILL REPORTEDLY BE A MAJOR FORUM FOR SOVIET TRADE AND DEVELOPMENT AS WELL AS SECURITY PROPOSALS.

### ISRAELI PLANES BOMBARD SOUTHERN LEBANON AGAIN

JULY 14 (IPS)-- ISRAELI PHANTOM JETS RAIDED PALESTINIAN REFUGEE CAMPS IN LEBANON YESTERDAY IN WHAT ARMED FORCES NETWORK RADIO HAS DESCRIBED AS "ONE OF THE BIGGEST" RAIDS IN RECENT MONTHS. OBSERVERS SAW "NO APPARENT REASON" FOR THE ATTACKS, ACCORDING TO AFN, BUT THE RAIDS COINCIDED WITH A MEETING OF THE ISRAELI CABINET WHICH HAD BEEN SCHEDULED TO DISCUSS ISRAEL'S STAND ON PEACE SETTLEMENTS IN THE MIDEAST.

THE FIRST ISRAELI BOMBING RAID WAS FOLLOWED BY A "GUERRILLA BOMBING" OF NORTHERN ISRAELI KIBDUTZES, WHICH IN TURN WAS FOLLOWED BY THE ISRAELI SHELLING OF A LEBANESE VILLAGE.

### ISRAELI CABINET STALLS DECISION ON MIDEAST SETTLEMENT

JULY 14 (IPS)-- THE ISRAELI CABINET SESSION OSTENSIBLY CALLED TO MAKE SOME DEFINITIVE ISRAELI MOVE TOWARD PEACE ENDED UP BY DOING NOTHING YESTERDAY. AN OFFICIAL COMMUNIQUE ISSUED BY THE CABINET STATED THAT ISRAEL WOULD CONTINUE "THE PROCESS OF CLARIFICATION AND NEGOCIATION WITH THE PURPOSE OF REACHING A POSITIVE CONCLUSION"-- THAT IS, STALL.

EARLIER IN THE DAY, ISRAELI PREMIER YITZHAK RABIN TOLD NEWSMEN IN TEL AVIV, "WE HAVE TO WORK CAREFULLY AND METHODICALLY WITHOUT BEING RUSHED." A PEACE SETTLEMENT, HE INSISTED, "IS NOT A MATTER OF ONE WEEK, OR TWO WEEKS AND PERHAPS NOT EVEN TWO MONTHS."

### WEST GERMAN BANKERS, CORPORATE PRESIDENTS RECIEVE INTRODUCTION TO U.S. LABOR PARTY

WIESBADEN, BRD, JULY 14 (IPS)-- THE FRANKFURTER ALLGEMEINE ZEITUNG (FAZ) WEST GEMANY'S MOST REPUTABLE AND WIDELY READ CAPITALIST DAILY, PUBLISHED A 900 WORD ARTICLE BY U.S. BASED JOURNALIST HANS JUERGENSEN ON THE NATIONAL CAUCUS OF LABOR COMMITTEES AND THE U.S. LABOR PARTY TODAY. THE ARTICLE, BASED ON A TWO HOUR INTERVIEW WITH MEMBERS OF THE NCLC NATIONAL EXECUTIVE COMMITTEE IN NEW YORK APPEARS UNDER THE HEADLINE "WHAT AMERICA'S LEFT DREAMS ABOUT; A POLITICAL DWARF SEES THE COLLAPSE OF CAPITALISM." SIGNIFICANTLY IT APPEARS IN THE FAZ' ECONOMICS SECTION.

AS JUERGENSEN REPORTS, THE INTERVIEW WAS SCHEDULED AFTER HE HAD PRINTED AN EARLIER PIECE ON THE U.S. LEFT, CLAIMING THAT NO WORKING CLASS MOVEMENT EXISTED IN THE UNITED STATES.

THE BODY OF THE ARTICLE OBJECTIVELY DESCRIBES THE NCLC'S INT'L ECONOMIC CONJUNCTURAL ANALYSIS WHICH JUERGENSEN DOES ENDORSE, BUT TAKES CARE TO IDENTIFY AS BEING IN THE TRADITION OF KARL MARX: "WITH ALL OF THEIR APPARENT INTELLECTUAL SHARPNESS, AMERICA'S NEW LEFT IDEOLOGUES HAVE APPARENTLY NOT AVOIDED THE SAME MISTAKE WHICH BROUGHT THEIR INTELLECTUAL FOREFATHERS, INCLUDING KARL MARX, INTO DIFFICULTY." SIGNIFICANTLY, JUERGENSEN THEN QUOTES AT LENGTH FROM THE CAMPAIGNER ON THEORETICAL AND POLITICAL POINTS RELATED TO THE ESTABLISHMENT OF WORKERS GOVERNMENT IN A PERIOD ON CONJUNCTURAL CRISES. HE NOTES IN DETAIL NCLC AND U.S. LABOR PARTY EXPOSES ON THE EXISTENCE OF A ROCKEFELLER CONTROLLED INTERNATIONAL POLITICAL CABAL, WHICH INCLUDES "HENRY KISSINGER,...LEONARD WOODCOCK,... FRENCH PRESIDENT GISCARD D'ESTAING, SWEDEN'S OLOF PALME.. AS WELL AS FEDERAL CHANCELLOR SCHMIDT AND SPD CHAIRMAN WILLY BRANDT."

#### DIE WELT BLAMES THIRD WORLD "MOUNTIAN OF DEBT" FOR CRISIS

WEISBADEN, JULY 14 (IPS)-- HEINZ PENTZLIN, ECONOMIC EDITOR FOR THE ULTRA CONSERVATIVE WEST GERMAN DAILY, DIE WELT TODAY BLAMED THE PRESENT ECONOMIC CRISIS OF THIRD WORLD COUNTRIES ON "THE MOUNTIAN OF DEBT (WHICH) HAS BEEN SHIFTED ON TO THEM." ACCORDING TO PENTZLIN, EVEN IF PROPAGANDA PROMISES OF ECONOMIC IMPROVEMENT IN THE WEST WERE FULFILLED AND EVEN WITH RISING WORLD BANK CREDITA "THIS WOULD HARDLY SUFFICE, THE MOUNTAIN OF DEBT IS GROWING TOO RAPIDLY."

THE FEATURED PENTZLIN EDITORIAL GIVES FURTHER IMPETUS TO WEST GERMAN INDUSTRIALISTS WHO ARE MOVING AWAY FROM ROCKEFELLER POLICY TOWARD THREE WAY EAST/WEST/THIRD WORLD TRADE AS PROPOSED BY THE ICLC AND THE SOVIET UNION.

JULY 14 (IPS)-- THE PRO-SOCIALIST POPULAR MOVEMENT FOR THE LIBERATION OF ANGOLA (MPLA) HAS DESTROYED THE LUANDA HEADQUARTERS OF THE CIA'S MAIN COUNTERGANG IN ANGOLA, THE NATIONAL FRONT FOR THE LIBERATION OF ANGOLA (FNLA), AND THE FNLA'S LEADERS HAVE FLED TOWARD ZAIRE, ACCORDING TO UPI AND SWEDISH RADIO, DAGENS EKO THIS MORNING. THE SOURCES ADDED THAT MPLA HAS ALSO OCCUPIED THE ZAIRE EMBASSY, THE FNLA'S IMMEDIATE CIA CONTROL CENTER AND

MPLA'S FIGHT TO COMPLETELY ELIMINATE THE NATIONAL FRONT FROM LUANDA'S PERIMETER IS ALMOST OVER.

#### SOVIETS WARN ASIAN NATIONS ON U.S. BASES

JULY 14 (IPS)-- THE SOVIET UNION'S DEFENSE MINISTRY WARNED ASIAN NATIONS THAT THEY COULD BE DRAWN INTO MILITARY CONFLICTS BY PERMITTING U.S. BASES ON THEIR SOIL. THE SOVIET DEFENSE MINISTRY NEWSPAPER, KRASNAYA ZVEZDA, IN A COMMENTARY COLUMN POINTED TO THE INDOCHINA WAR AS AN EXAMPLE OF THE DANGER OF US BASES AND WENT ON TO SAY "COUNTRIES THAT PERMIT BASES ON THEIR SOIL MAY BE PULLED INTO A MILITARY ADVENTURE, AS THE WAR SHOWED, EVEN AGAINST THEIR WISHES."

#### INDIAN LABOR MINISTER ACCUSES CHINA OF DAMAGING WORLD PEACE

JULY 14(IPS)-- AT A MAJOR RALLY IN NEW DELHI TODAY, INDIAN LABOR MINISTER RAGUNNATHA REDDY ACCUSED "CHINA OF ACTIONS IN CONCERT WITH THE CAMP OF WORLD REACTION" THAT ENDANGER WORLD PEACE, ACCORDING TO A BROADCAST OF STIMME DER DDR, OFFICIAL EAST GERMAN RADIO TODAY. REDDY STATED THAT CHINA'S PRESENT FOREIGN POLICY "DAMAGES WORLD STABILITY AND THE FORCES OF IMPERIALISM AIM TO MISLEAD THE COUNTRIES IN ASIA, AFRICA, AND LATIN AMERICA FROM THE WAY THEY HAVE CHOSEN," REDDY THEN THANKED THE SOVIET UNION, EASTERN EUROPE AND OTHER NONALIGNED

PRO-DEVELOPMENT FORCES FOR THEIR SUPPORT IN FIGHTING AGAINST "THIS CONSPIRACY," SAID THE EAST GERMAN RADIO.

#### II. CONTINENTAL

OTTINGER HITS WASHINGTON POST,  
EDITORS RESPOND WITH LIES

JULY 14 (IPS)--REPRESENTATIVE RICHARD OTTINGER (D-N.Y.)

IN A LETTER TO THE EDITORS OF THE WASHINGTON POST CALLS THEM TO TASK FOR LABELING THE ISSUE OF THE SCHLESINGER DOCTRINE ON NUCLEAR WEAPONS A "FIRST USE HUBSUB" AND "POLITICAL HULLABALOO." OTTINGER REITERATES HIS CONGRESSIONAL RESOLUTION SIGNED BY 90 COLLEAGUES TO RENOUNCE THE FIRST USE MADNESS. THE POST'S REPLY TO THIS MEASURED

CRITICISM OF ITS POSITION IS A COVER UP OF ALL THE SUBSTANTIVE ISSUES INVOLVED. IGNORING THE DEFENSE POLICY SHIFTS STATED AND DEFENDED BY PRESIDENT FORD AND DEFENSE SECRETARY SCHLESINGER, THE POST EDITORS

REITERATE THEIR POSITION THAT "THE FIRST USE HUBBUB IS IN FACT JUST THAT: A SUDDEN POLITICAL SQUALL OVER A POLICY POSITION THAT HAS

GONE UNCHALLENGED FOR SOMETHING LIKE 25 YEARS."

THE POST FURTHER LIES THAT ANY STATED POSITION OR "PLEDGE" AGAINST FIRST USE WOULD BE OF NO CONSEQUENCE ANYWAY SINCE IN A "DESPERATE WARTIME SITUATION" SUCH AGREEMENTS "DEPOSITED IN AN ARCHIVE" WOULD BE WORRITLESS SCRAPS OF PAPER.

FORMER CIA DIRECTOR HELMS ATTACKED FOR CIA COVERUP

JULY 14 (IPS)-- WITH CHARGES OF ILLEGAL CIA ACTIVITIES FLYING THROUGH WASHINGTON, NEW YORK TIMES COLUMNIST ANTHONY LEWIS TODAY ATTACKS FORMER CIA DIRECTOR RICHARD HELMS FOR BLATANTLY LYING ABOUT CIA ACTIVITIES IN CHILE, THE WATERGATE OPERATION AND THE ANTI-WAR MOVEMENTS. LEWIS ARGUES THAT CONGRESS, FORD AND THE ROCKEFELLER COMMISSION REPORT SHOULD HAVE CENSURED HELMS FOR PERJURY

AND REMOVED HIM FROM HIS CURRENT POST AS US AMBASSADOR TO IRAN. LEWIS TERMS THE ROCKEFELLER CIA REPORT "COMPREHENSIVE" MAKES NO MENTION

OF ONCE CIA DIRECTOR SCHLESINGER'S COVER-UP ACTIVITIES, AND POINTS THE FINGER AT HELMS, WHO IS REGARDED BY INFORMED SOURCES

AS A LIKELY SCAPEGOAT.

CIA-FBI SPREAD SWAT UNITS

JULY 14 (IPS)--THE CIA-INSPIRED SPECIAL WEAPONS AND TACTICS (SWAT) SQUADS ARE SPREADING NATIONWIDE TO BOTH SMALL AND BIG-CITY POLICE DEPARTMENTS, ACCORDING TO TODAY'S NEW YORK TIMES. THE TIMES CITES SEVERAL POLICE CHIEFS WHO SEE THE SWAT UNITS AS A "DANGEROUS EXTENSION OF A MACHO SYNDROME" ALREADY PREVALENT AMONG THE POLICE.

ACCORDING TO AN FBI SPOKESMAN, THE PROGRAM WAS ESTABLISHED NEARLY FOUR YEARS AGO "IN RESPONSE TO A NATIONAL RISE IN CIVILIAN DISTURBANCES" BUT ONE PLAIN-TALKING POLICE OBSERVER SAID THAT SWAT IS AIMED AT "COUNTER-INSURGENCY ACTIONS AGAINST REVOLUTIONARIES OR MILITANT MINORITIES."

THE TIMES REPORTS THAT SWAT UNITS RECEIVE THEIR TRAINING WHICH INCLUDES PSYCHOLOGICAL TECHNIQUES, AND "WEAPONS AND MILITARY ASSAULT TACTICS," AT THE FBI ACADEMY IN QUANTICO, VA. ON THE MARINE CORPS BASE THERE. 467 POLICE AGENCIES HAVE ALREADY RECEIVED SWAT TRAINING AND 200 MORE POLICE TEAMS ARE NOW AWAITING TRAINING, ALMOST EXCLUSIVELY MADE POSSIBLE BY LEAA FUNDING. IN ADDITION THE FBI IS "ASSISTING CANADIAN OFFICIALS IN THE DEVELOPMENT OF A SWAT-LIKE CAPABILITY."

SUPREME COURT DENIES RECOURSE TO FEDERAL COURT

JULY 14 (IPS)--THE UNITED STATES SUPREME COURT HAS "CLOSED THE DOORS OF THE FEDERAL COURTS TO THOUSANDS OF PEOPLE SEEKING REDRESS" FOR GRIEVANCES, REPORTS TODAY'S WASHINGTON POST. THE SUPREME COURT'S RULING ELIMINATES RECOURSE TO THE FEDERAL COURTS FOR PERSONS SUBJECT TO STATE PROSECUTION IF THE STATE OR LOCAL PROSECUTOR FILES A CRIMINAL CHARGE BEFORE THE FEDERAL COURT HAS TAKEN ANY SIGNIFICANT ACTION TO BLOCK THE CRIMINAL CASE. JUSTICE POTTER STEWART, A DISSENER, SAID THAT THE RULING "OUSTS THE FEDERAL COURTS FROM THEIR HISTORIC ROLE AS THE PRIMARY RELIANCES FOR VINDICATING CONSTITUTIONAL FREEDOMS," ACCORDING TO THE POST.

THE SUPREME COURT ALSO RULED THAT FEDERAL JUDGES SHOULD STAY OUT OF MILITARY COURTMARTIAL MATTERS WHILE SUCH TRIALS ARE GOING ON, EVEN WHEN IT SEEMS THE PROCEEDING IS UNCONSTITUTIONAL.

THESE RULINGS ARE STRICTLY IN LINE WITH THE ROCKEFELLER ADMINISTRATION'S EFFORTS TO UNDERMINE THE LEGAL FRAMEWORK OF AMERICAN CONSTITUTIONAL DEMOCRACY THROUGH SUCH LEGISLATIVE ACTS AS SENATE BILL 1.
