ONE LABOR PARTY MEMBER INSIDE YPSILANTI FORD REPORTED EARLIER IN THE WEEK THAT THE SPEEDUP INITIATED WITH THE SHIFT RETURN ON MONDAY WAS THE MOST BRUTAL RATE EVER FORCED ON WORKERS THERE. HE REPORTED THAT AFTER ONE DAY BACK, HE WAS LAID UP IN BED FOR 24 HOURS.

"HOMEFRONT"/CREEP MAILS SLANDER
ON USLP/NCLC TO "CIVIC LEADERS"

NEW YORK, JULY 31 (IPS)—THE SECURITY STAFF OF THE NATIONAL CAUCUS OF LABOR COMMITTEES (NCLC) LEARNED TODAY THAT SEVERAL PRESS CONTACTS SYMPATHETIC TO THE LABOR PARTY HAVE RECENTLY RECEIVED A MAILING FROM THE WASHINGTON-BASED INSTITUTE FOR AMERICAN DEMOCRACY, PUBLISHERS OF THE MONTHLY THROWAWAY HOMEFRONT, DEMANDING DETAILED INFORMATION ON LABOR PARTY/NCLC ORGANIZING IN THEIR AREAS.

A LETTER ADDRESSED TO "CIVIC LEADERS" AND RECEIVED THUS FAR BY CONTACTS IN BUFFALO-ROCHESTER, BOSTON, AND CHARLOTTE AREAS REQUESTED IMMEDIATE RESPONSE TO THE FOLLOWING QUESTIONS:

- "(1) WHAT USLP CANDIDATES ARE RUNNING FOR OFFICES IN YOUR REGION?
- "(2) HAVE CITY OFFICIALS BEEN SUBJECTED TO HARASSMENT BY THIS GROUP?
- "(3) IS NEW SOLIDARITY BEING HAWKED IN THE STREETS?
- "(4) DO YOU HAVE AN ESTIMATE OF THE SIZE OF NCLC CADRE?"

ACCOMPANYING THE INFORMATION REQUEST WAS A COPY OF THE APRIL ISSUE OF HOMEFRONT, DEVOTED IN ITS ENTIRETY TO SLANDERING THE NCLC AND ITS CHAIRMAN, U.S. LABOR PARTY PRESIDENTIAL CANDIDATE LYNDON LAROCHE, JR.

PRELIMINARY NCLC INVESTIGATIONS HAVE DETERMINED THAT THE IAD/HOMEFRONT SLANDER MACHINE WAS SET UP TO PREVENT CERTAIN CANDIDATES OUTSIDE THE REPUBLICAN OR DEMOCRATIC PARTIES FROM ENTERING THE ELECTORAL PROCESS, SPECIFICALLY TARGETING ALABAMA GOVERNOR GEORGE WALLACE. THE OPERATION WAS ESSENTIALLY INCORPORATED INTO THE CIA/ JUSTICE DEPARTMENT-RUN CREEP (COMMITTEE TO RE-ELECT THE PRESIDENT)
