# Get On Board the New Paradigm Sweeping the Planet

Our government must accept the offer China made at the G-20 Summit and join the new paradigm of economic development and cooperation. That is the vehicle by which we can return to our own founding principles. But it will only happen when the people of the United States stop being soft on the murderous policy

being carried out by President Obama on behalf of the British-Saudi alliance—an alliance for destruction that he has vowed to defend and protect, as emphatically confirmed by his veto of the Justice Against Sponsors of Terrorism Act (JASTA). His veto must be overridden, and we must demand his removal from office now, for the high crimes and indeed the treason that he has committed against this nation.

Before Obama's veto of JASTA, Lyndon LaRouche warned that it was already expected that Obama would veto it, "because he is an agent of the British system." This act of treason against the American people warrants Obama's immediate impeachment.

It is imperative that the American people understand that we are up against a collapsing empire and its financial oligarchy that are out to create total chaos and destruction to put an end to the new paradigm for economic and scientific progress that is already in the process of being created. This empire and its stooge Obama continue to stand in the way, as the very antithesis of economic development and cooperation, but they are vulnerable and can be defeated.

Over the last several weeks, with the G-20 Summit in Hangzhou led by China, followed by the meeting of the UN General Assembly, it has become clear that there are two systems before the world. As Helga Zepp-LaRouche made clear in her appeal to the UN General Assembly after the G-20 had met, "The course has been set toward a new financial architecture, and the chance is greater than ever that all nations can participate in the building of the New Silk Road on the basis of win-win cooperation, and that the productivity of the world economy will rise on the basis of innovation, while poverty and the consequences of war are overcome."

### **Vision of the Hongzhou G-20 Summit**

China, joined by Russia and other leading nations throughout the world, continues to stand strong against the geopolitical agenda of global dominance, the agenda of a unipolar world that seeks to keep whole populations of the world backwards and enslaved.

China and the other participants of the G-20 Summit, in their [final communiqué](#), expressed the belief that "Closer partnership and joint action by G-20 members will boost confidence in, foster driving forces for, and intensify cooperation on global economic growth, contributing to shared prosperity and

better well-being of the world." The G-20 leaders also state, "We are determined to foster an innovative, invigorated, interconnected and inclusive world economy."

The vision of the Hangzhou G-20 Summit includes the reaffirmation of "our commitment to promote investment with focus on infrastructure in terms of both quantity and quality. We welcome the [Joint Declaration of Aspirations on Actions to Support Infrastructure Investment](#) by eleven multilateral development banks, including their announcements of quantitative ambitions for high-quality infrastructure projects within their respective institutional mandates . . ."

These eleven multilateral development banks call for up to \$1.5 trillion to be invested in infrastructure in the developing world, annually, for the next 15 years. Of this amount, these banks currently commit around \$150 billion annually—which in itself is about one-and-a-half times the amount that Obama is spending annually to upgrade the United States' nuclear arsenal to a global first-strike capability. These eleven banks are investing in New Deal style projects, including the building of new and upgraded rail systems, power grids, and advanced agro-industrial projects. There is obviously plenty of room here for U.S. cooperation.

A new paradigm is now sweeping the planet. Our nation and its youth deserve to be a part of such a beautiful future. It is being led by China and Russia, through "development corridor" projects such as the New Silk Road, to which governments representing more than 70 percent of the world's population have made commitments. But Obama not only rejects this beautiful new paradigm in which we have a rightful place: He is determined to halt it as soon as possible—in behalf of his allegiance to an evil empire.

Obama cuts our space program, denying access to scientific progress, while China now leads the charge in defining mankind's extraterrestrial imperative in the development of space, going to the far side of the moon, investing in advanced hypersonic spacecraft, organizing cooperation in space with most of the world for a space station set to be launched by 2020. All this, while Obama is supporting terrorism, promoting conflict and war, and protecting Wall Street's looting of the productive economy, all on behalf of a dying British Empire.
