I. PRIORITIES.

EAST GERMANY ATTACKS BRD TRADE-WAR MANEUVERS

SEPT. 9 (IPS)--EAST GERMAN (DDR) PRESS TODAY ACCUSED "INTERESTED CIRCLES" IN WEST GERMANY (BRD) OF SPREADING SLANDERS THAT THE DDR BEEN "DUMPING" CHEAP GOODS ON THE BRD MARKET.

"IN THE BRD," STATED NEUES DEUTSCHLAND, THE COMMUNIST PARTY NEWSPAPER, "THERE IS AN APPRECIATION THAT TRADE BETWEEN THE BRD AND DDR CAN ONLY HAVE STRONG FOUNDATIONS IF IT IS MUTALLY ADVANTAGEOUS. IN ORDER TO INTIMIDATE THESE REALISTIC THINKERS, INTERESTED CIRCLES IN THE BRD HAVE RECENTLY PUT THIS IDEA ABOUT DDR 'DUMPING' INTO CIRCULATION."

NEUES DEUTSCHLAND WARNED THAT TRADE CANNOT BECOME A "ONE-WAY STREET. THIS REQUIRES AN INCREASE IN THE BRD'S WILLINGNESS TO PUT DDR GOODS ON ITS MARKET. OTHERWISE, THE DDR WILL BE FORCED TO SHARPLY CURB ITS PURCHASES FROM THE BRD."

MOOT CARVALHO LED COUP IN PORTUGAL

SEPT. 9 (IPS)--A SPOKESMAN FOR THE U.S. BASED THINK-TANK SPECIALIZING IN COMMUNIST AFFAIRS, TODAY PREDICTED THAT THE CURRENT POLITICAL CRISIS IN PORTUGAL WILL RESULT IN COUP D'ETAT LED BY MAOIST GEN. OTELO CARVALHO, HEAD OF THAT COUNTRY'S SECURITY FORCES. THE CARVALHO TAKEOVER WOULD LEAD TO A GOVERNMENT "ALONG THE LINE OF WHAT PERU WAS ORIGINALLY...", THE SOURCE TOLD IPS.

IL GLOBO, THE ITALIAN DAILY, PARTIALLY OWNED BY THE CEFIS INDUSTRIAL FACTION, TODAY MOOTED AN ALMOST IDENTICAL SCENARIO AS A SOLUTION TO "THE PORTUGUESE PROBLEM." A CARVALHO-LED COUP, IL GLOBO WRITES, "IS A POSSIBLE SOLUTION TO THE (PORTUGUESE) CRISIS." "SUCH A COUP," THE PAPER CONTINUES, COULD TAKE THE FORM OF A "NATIONAL ROAD TO SOCIALISM, LIKE THAT OF PERU."

GONCALVES GOVERNMENT TO CONTINUE UNTIL AZEVEDO GOVERNMENT FORMED

SEPT. 9 (IPS)--PORTUGAL'S 5TH PROVISIONAL GOVERNMENT, LED BY GEN. VASCO GONCALVES, HAS ISSUED A COMMUNIQUE SAYING IT WILL SERVE ON AN INTERIM BASIS UNTIL THE NEW GOVERNMENT UNDER ADMIRAL PINHEIRO DE AZEVEDO HAS BEEN FORMED, ACCORDING TO NBC.

REVOLUTIONARY COUNCIL REINSTATES TWO NATO AGENTS

SEPT. 9 (IPS)--PORTUGAL'S NEW REVOLUTIONARY COUNCIL OF 21 HAS REINSTATED TWO U.S. STATE DEPARTMENT/NATO AGENTS -- MAJ. ERNESTO DE MELO ANTUNES AND MAJ. VITOR ALVES -- AS MEMBERS OF THE COUNCIL. ALSO REINSTATED IS MAJ. JOSE COSTA MARTINS, A PRO-WORKING CLASS OFFICER AND PORTUGAL'S LABOR MINISTER, EAST GERMAN RADIO REPORTS TODAY.

THE REINSTATEMENT OF SOCIAL DEMOCRATS ANTUNES AND ALVES, PREVIOUSLY EXPELLED FROM THE REVOLUTIONARY COUNCIL, GIVES THAT BODY A DECIDED ANTI-COMMUNIST CAST.

HUMPHREY ALLIES HIMSELF
WITH PALME, BRANDT, WILSON ON PORTUGAL

UNITED NATIONS, SEPT. 9 (IPS)--SEN. HUBERT HUMPHREY (D-MN), FRESH FROM MEETINGS WITH "COMMITTEE TO INTERFERE IN PORTUGAL" LEADERS OLOF PALME AND HAROLD WILSON LAST WEEK IN LONDON, TOLD AN IPS REPORTER TODAY, WHEN ASKED ABOUT HIS SUPPORT FOR PSP LEADER MARIO SOARES, "I JUST WANT TO SEE A NON-COMMUNIST GOVERNMENT IN PORTUGAL."

WHILE HUMPHREY DENIED ATTENDING ANY OF THE MEETINGS OF THE SOCIAL DEMOCRATS' COUNTER-REVOLUTIONARY LONDON GATHERING, HE DID ADMIT TO HAVING MET EXTENSIVELY "IN PRIVATE" WITH PALME AND DISCUSSING "MANY ISSUES." LATER IN THE DAY, IPS LEARNED THAT THE OLD SOCIAL DEMOCRATIC WARHORSE FROM MINNESOTA MET WITH BRITISH PRIME MINISTER WILSON ON FRIDAY AND DISCUSSED PORTUGAL. THIS OCCURRED AT THE SAME TIME WILSON, PALME AND WILLY BRANDT WERE PLANNING THEIR INTERVENTION INTO PORTUGAL.

SEN. CLARK MOVES TO EXPOSE U.S. INVOLVEMENT IN ANGOLA;
STUDYING PORTUGUESE SITUATION

SEPT. 9 (IPS)--SEN. DICK CLARK (D-IOWA), BACK FROM A FACT-FINDING TOUR OF AFRICA, HAS CALLED FOR THE SENATE FOREIGN RELATIONS COMMITTEE, OF WHICH HE IS A MEMBER, TO INVESTIGATE U.S. INVOLVEMENT AND INTERFERENCE IN ANGOLA. AN AIDE TO SEN. CLARK TOLD IPS TODAY THAT CLARK IS PREPARED TO SUBMIT TO CONGRESS, AN AMENDMENT TO THE FOREIGN ASSISTANCE ACT, IF THE FOREIGN RELATIONS COMMITTEE FAILS TO ACT.

WHEN ASKED IF THE SENATOR WOULD ATTACK SIMILAR U.S. SABOTAGE IN PORTUGAL, THE AIDE SAID THAT CLARK "WAS STUDYING THE SITUATION CAREFULLY."

FBI REVEALS FAR-REACHING INVESTIGATION OF USLP/NCLC

PORTLAND, SEPT. 9 (IPS)--FBI DIRECTOR CLARENCE KELLY REVEALED OPENLY TODAY WHAT HAS LONG BEEN FBI POLICY TOWARD THE NATIONAL CAUCUS OF LABOR COMMITTEES: AN HYSTERICAL COINTELPRO OPERATION AIMED AT RESURRECTING THE MCCARTHY ERA AND ITS SUBSUMED CRIMINAL INVESTIGATIONS AND WHOLESALE PILLAGE OF CIVIL RIGHTS IN THE UNITED STATES.

THE KELLY REVELATIONS CAME IN A LETTER TO NCLC MEMBER CRAIG SCHULTZ IN PORTLAND FOLLOWING SCHULTZ'S REQUEST FOR RELEASE OF HIS FILES UNDER THE FREEDOM OF INFORMATION ACT. THE ENTIRE LABOR COMMITTEES ORGANIZATION IS PRESENTLY ENGAGED IN A POLITICAL AND LEGAL CAMPAIGN TO GAIN RELEASE OF THE "NCLC PAPERS" FROM VARIOUS GOVERNMENT AGENCIES UNDER THE FREEDOM OF INFORMATION ACT.

IN HIS LETTER TO SCHULTZ, KELLY SAID, "YOU ARE BEING INVESTIGATED FOR REBELLION OR INSURRECTION, SEDITION CONSPIRACY, ADVOCATING OVERTHROW OF THE GOVERNMENT, ANTI-RIOT LAWS, AND VIOLATION OF THE SECURITY ACTS OF 1970, 1950, AND THE COMMUNIST CONTROL ACT OF 1954." IN ADDITION, FILES WERE RELEASED TO SCHULTZ WHICH INDICATE MAJOR FBI SURVEILLANCE OF THE NCLC NATIONAL CONFERENCE IN MAY OF 1974.

THE SCHULTZ LETTER FOLLOWS BY TWO WEEKS A DECLARATION BY KELLY THAT THE NCLC WAS UNDER INVESTIGATION BY THE FBI FOR POSSIBLE CRIMINAL CHARGES AS A VIOLENCE-PRONE GROUP. KELLY WROTE THIS LETTER IN RESPONSE TO A LETTER FROM CONGRESSMAN DONALD RIEGLE OF MICHIGAN. RIEGLE HAD FORWARDED A LETTER FROM DETROIT LAWYER MAX DEAN CALLING FOR CONGRESSIONAL INVESTIGATION OF FBI COINTELPRO OPERATIONS AGAINST THE LABOR COMMITTEES.

THE FBI "OFFICIALLY" OPENED THIS CAMPAIGN IN FEB., 1975 BY USING THE U.S. IMMIGRATION AND NATURALIZATION SERVICE TO EXCLUDE NORTH AMERICAN LABOR PARTY MEMBERS FRANCOIS BIERRE AND GIANCARLO DALLAVILLE FROM ENTRY INTO THE UNITED STATES UNDER 8 USC 1182 (A) (G), THE MCCARREN ACT SECTIONS OF THE U.S. IMMIGRATION CODE. HEARINGS CONCERNING THE EXCLUSION OF THE NALP MEMBERS FROM THE UNITED STATES WILL BEGIN AGAIN SOON IN SEATTLE AFTER A REPLACEMENT OF THE INITIAL IMMIGRATION JUDGE GREENWALT, WHO DISQUALIFIED HIMSELF FOR "BEING AN ANTI-COMMUNIST."

NCLC LEGAL STAFFS ANNOUNCED TODAY THAT THEY WILL PRESS FOR FULL LEGAL AND CONGRESSIONAL INQUIRIES INTO THE FBI REVELATIONS.

BOSTON CITY COUNCIL VOTES ITSELF OUT OF OFFICE;
KILLS DEBT MORATORIUM

SEPT. 9 (IPS)--THE BOSTON CITY COUNCIL EFFECTIVELY VOTED ITSELF OUT OF POLITICAL EXISTENCE YESTERDAY BY KILLING COUNCILMAN ALBERT O'NEIL'S DEBT MORATORIUM RESOLUTION BY A 7 TO 1 VOTE.

THE ENTIRE COUNCIL, EXCEPT FOR LARRY DICARA, CHAIRMAN AND SELF-APPOINTED DEBT MORATORIUM OPPONENT, LEFT THE ROOM AS O'NEIL BEGAN SPEAKING TO MOTIVATE THE RESOLUTION. FORMER OSS AGENT COUNCILMAN LAGONE STAYED IN THE MEN'S ROOM LONG ENOUGH TO MISS THE VOTE.

U.S. LABOR PARTY MAYORAL CANDIDATE ROBERT GIBBONS WILL USE THE COUNCIL'S VOTE TO FUEL HIS CAMPAIGN IN THE REMAINING TWO WEEKS BEFORE THE SEPT. 23 PRIMARY.

NYC TEACHERS STRIKE BEGINS;
SHANKER HITS BANKS, CITY GOVERNMENT

NEW YORK, SEPT. 9 (IPS)--SPEAKING AT A PRESS CONFERENCE HERE THIS AFTERNOON, UNITED FEDERATION OF TEACHERS (UFT) PRESIDENT ALBERT SHANKER REPORTED THAT THE STRIKE OF HIS 80,000 MEMBER UNION WAS "EXTREMELY EFFECTIVE." PICKET CAPTAINS REPORTED TO THE UFT LEADERSHIP "ONLY 600 SCABS HAD CROSSED PICKET LINES IN THE ENTIRE CITY." "MORE THAN 90 PERCENT OF CITY SCHOOLS WERE COMPLETELY SHUT DOWN," CBS RADIO REPORTS.

THE UFT PRESIDENT, REITERATING STATEMENTS MADE LAST NIGHT AT THE MASS UFT MEETING WHICH APPROVED THE STRIKE, STATED THAT "THE ISSUE IS NOT TEACHERS' SALARIES...WE CANNOT ACCEPT THE BOARD OF EDUCATION'S PRESENT OFFER...IT WOULD CREATE CHAOS AND DESTROY THE SCHOOL SYSTEM. WE WILL STAY OUT AS LONG AS IT TAKES TO GUARANTEE THE CHILDREN OF THIS CITY A DECENT EDUCATION."

REFERRING TO THE MORE THAN \$200 MILLION IN CUTS ORDERED BY THE BOARD OF EDUCATION, SHANKER STATED, "THE BANKS SEEM TO THINK THAT EVERYBODY IN THIS CITY SHOULD BE HURT -- EVEN CHILDREN -- BEFORE THEY ARE..."

IMPLICITLY CHIDING THE WEAK CITY GOVERNMENT FOR CAPITULATING TO THE BANKERS' DEMANDS TO CEDE ITS AUTHORITY TO "BANKERS' DIRECTORATE," SHANKER ANGRILY STATED, "I KNOW THERE IS A CITY GOVERNMENT OUT THERE SOMEWHERE...WON'T IT PLEASE STEP FORWARD SO WE CAN BEGIN MEANINGFUL NEGOTIATIONS..."

THE UFT AND THE BOARD OF EDUCATION ARE SCHEDULED TO RESUME NEGOTIATIONS LATER THIS AFTERNOON.

WHITMAN CAMPAIGN WORKER SUPPORTS DRUGS

SEPT. 9 (IPS)--CITY COUNCIL CANDIDATE GREN WHITMAN, AT A BALTIMORE SHOPPING CENTER HERE YESTERDAY, PUBLICLY ENDORSED THE LEGALIZATION OF HEROIN. IN FRONT OF A CROWD OF WORKERS GATHERED TO LISTEN TO A LABOR PARTY RALLY, WHITMAN'S CAMPAIGN WORKER DECLARED, WHEN CONFRONTED ON HIS STAND ON METHADONE, THAT "FRANKLY I DON'T LIKE METHADONE EITHER. I THINK HEROIN SHOULD BE LEGALIZED."

WHEN WORKERS DEMANDED TO KNOW WHETHER HE TOOK DRUGS HIMSELF, THIS DEGENERATE RESPONDED, "OF COURSE. I'M A CHEMISTRY STUDENT AT THE UNIVERSITY OF MARYLAND. I WORK HARD ALL DAY. I NEED SOMETHING TO RELAX AT NIGHT."

THE BALTIMORE SUN RECENTLY ENDORSED THE CANDIDACY OF WHITMAN, NOTORIOUS FOR AFFILIATION WITH THE "MAN ALIVE" METHADONE CENTER.

NEW YORK LEGISLATURE PASSES NEW BIG MAC PROPOSAL

SEPT. 9 (IPS)--THE NEW YORK STATE SENATE TODAY FINALLY VOTED UP THE NEW BIG MAC PROPOSAL FOR REORGANIZATION OF NEW YORK CITY FIN-

ANCES, AND ADJOURNED. THE STATE ASSEMBLY LATE LAST NIGHT PASSED THE MEASURE BY A 80 TO 70 MARGIN. GOV. HUGH CAREY IS EXPECTED TO SIGN THE MEASURE INTO LAW TONIGHT.

OF THE \$2.3 BILLION PACKAGE TO BAIL OUT NEW YORK CITY UNTIL DECEMBER, PUT TOGETHER IN THE MAC LEGISLATION, ONLY THE LOOTING OF \$725 MILLION FROM THE PENSION FUNDS OF STATE AND CITY WORKERS IS A RELATIVELY "SURE THING". THE REST OF THE MONEY IS TO BE OBTAINED BY THE STATE BORROWING \$750 MILLION IN TAX ANTICIPATION NOTES FOR THE CITY AND ANOTHER \$800 MILLION FROM GOVERNMENT AND "PRIVATE FINANCIAL SOURCES" -- (NAMELY THE ROCKEFELLER NEW YORK BANKS). PROSPECTS OF RAISING THE MONEY ARE TERMED "HIGHLY DOUBTFUL" BY FINANCIAL SOURCES.

THE NEW MAC LEGISLATION ALSO CREATES A 7-PERSON STATE EMERGENCY CONTROL BOARD TO ENFORCE CUTBACKS, WHICH TODAY'S NEW YORK TIMES GLOATS WILL BE "EVEN MORE SEVERE THAN THE MEASURES TRIED EARLIER BY MAYOR BEAME."

INFORMED SOURCES IN ALBANY INDICATED THAT ALTHOUGH THE SEPCIAL SESSION CALLED BY GOV. CAREY TO CONSIDER THE MAC PLAN IS NOW IN RECESS, THE LEGISLATURE WILL RECONVENE WITHIN THE NEXT MONTH. SOURCES CITED THE GOVERNOR'S STATEMENT LAST WEEK THAT THE LEGISLATURE WOULD HAVE TO REMAIN IN SESSION A FULL MONTH TO WORK OUT THE DETAILS OF THE MANAGED DEFAULT PROCEEDINGS, AS MEANING THAT THE SESSION'S WORK IS STILL UNCOMPLETED.

SEVERAL NEW YORK CITY LIBERAL DEMOCRATS INDICATED THAT THEY PLANNED TO RETURN TO ALBANY IN TWO WEEKS AND INTRODUCE A DEBT MORATORIUM RESOLUTION WHICH WOULD DO AWAY WITH THE MAC PLAN.
