

# British Oligarchs Run Soros Addiction Drive

The international drug-legalization strike force, for which George Soros is the frontman and moneybags, is determined that the moment has arrived to go for mass addiction of the world's populations, to ensure all civilization collapses along with their masters' financial system.

When Lyndon LaRouche called for sovereign nations to join together to crush the new British Opium War, he hit it on the mark. Over the past five years, the slime mold of Soros-financed, drug-pushing NGOs proliferating across the globe has been shaped into a "focussed, disciplined, inter-connected and organized" strike force, directed from the top by the highest levels of the British oligarchy. That strike force is now out to legalize opium in Afghanistan and the coca trade in the Andes, to break the international community's will to crush the drug trade, and to begin to dismantle institutions of global cooperation against narcotics traffic, by the March 2009 Ministerial of the UN Commission on Narcotic Drugs (CND) in Vienna, Austria.

They are gunning to do now, what they were unable to do ten years ago, at the 1998 UN General Assembly Special Session on Drugs. At that time, Soros mobilized dozens of "people in high places" (including that Pinochet-sponsor who gave us Bush-Cheney, George Shultz) to publicly call upon the United Nations to formally declare an end to the policy of fighting the global drug trade. That gambit failed, but the legalizers have regrouped, expecting the ground they gained in the meantime, under global collapse and pessimism, to bring victory.

## The Ibero-American Flank

A Latin American Commission on Drugs and Democracy was established in Rio de Janeiro in April 2008, to centralize the Ibero-American side of this offensive. The 18 self-described "distinguished" men and women making up the commission stated that their

job is to ensure that "the voice of Latin America" is heard at the March 2009 CND meeting in Vienna. But, the only voice speaking in this show is that of British agent George Soros.

Soros's Open Society Institute (OSI) is a top funder of the Commission, and the three "experts" brought in to address its founding meeting were all from Soros's stable of agents. Not surprisingly, the agenda adopted is also that of Soros: attempts to control the production of drugs have failed, and combatting drugs is too expensive, anyway; society should give up the idea of getting rid of narcotics and capitulate to drug "decriminalization."

The Commission is co-chaired by three former Presidents: Brazil's Fernando Henrique Cardoso (1995-2003), Colombia's César Gaviria (1990-94), and Mexico's Ernesto Zedillo (1994-2000). Each in their day was an avid implementer of London's free-trade and privatization policies which fostered the dope trade which now controls entire economies and nations in the region. Gaviria, in particular, is infamous for having knowingly permitted the drug mafia to control the 1991 Constituent Assembly which rewrote Colombia's Constitution.

## 'Left-Right' Polarization

Ibero-Americans drawn into the dangerous polarization between "socialist left" vs. "democratic right," which threatens to rip the region (and the nation of Bolivia) apart, would do well to consider the implications of leaders of both "sides" happily joining forces on Soros's "drugs and democracy" commission.

A key role in the Commission is being played by Amsterdam's nominally left-wing, Soros-funded Transnational Institute (TNI). TNI, with Soros's OSI, ran the Coca 90's project, which a decade ago organized the coca-growers in the Andes as a battering ram for legalization. Another key agent in that Coca 90's project, Peru's Diego García-Sayán, Soros-financed in his own right, is a member of the Commission.

Among the other members of the Commission are such well-known British agents as Brazil's João Roberto Marinho, the former head of Prince Philip's genocidal Worldwide Fund for Nature (WWF) in Brazil, and Peru's perverse liberal, Mario Vargas Llosa, whose 1990 Presidential campaign was run by Soros's *compadre*, Lord Mark Malloch-Brown, today U.K. Minister for Africa, Asia, and the United Nations. No one could call either a "leftist."

TNI's Martin Jelsma, active in the British "poppy for medicine" Afghanistan opium legalization scam, as well as a leader of the "coca for tea" cocaine legalization hoax, told the Commission that, "there is not going to be a world rid of drugs." Therefore, your job is to turn away from the "U.S. approach" of a war on drugs, toward the "European approach" of "harm reduction."

Jelsma's coca legalization hoax (see accompanying article "Coca: The Sacred Leaf Of British Imperialism") with the British government's opium gambit exposed in the Aug. 22 *EIR* article, "Afghan Opium Pleases Taliban and Soros," are central to Soros's overall 2009 narco-strategy.

The other two "experts" addressing the meeting are also Soros boys: Rubem César Fernandes, director of Brazil's Viva Rio NGO, a leading OSI "democracy" project; and former RAND Corporation analyst Peter Reuter, who today chairs the Soros-linked International Society for the Study of Drug Policy.

### **Holes in Their Heads**

Reuter brings us to a deeper level of this matter. The International Society for the Study of Drug Policy, like its sister association, the International Drug Policy Consortium, which unites some 25 international "drug policy reform" NGOs (most, if not all, financed by Soros), was founded out of a seminar held in the British House of Lords in 2004.

The seminar was organized by the Beckley Foundation, whose founder and director is one Amanda Feilding, aka Lady Neidpath, wife of the heir apparent to the Earldom of Wemyss and March. Receiving major funding from Soros's Open Society Institute since 2000, the Beckley Foundation has played a central role in his international drug legalization lobby.

Lady Neidpath's Beckley Foundation doesn't bother to hide its objectives under the fig-leaf euphemisms of "harm reduction," etc. with which the Soros crew assuages the consciences of government officials capitulating to Soros. Originally named the "Foundation To Further Consciousness," the Beckley Foundation openly campaigns for the mass use of psychoactive drugs for "expanding consciousness" and "altered states."

One might expect no less from advocates of the medieval practice of trepanation. Lord and Lady Neidpath drilled holes in their skulls in the 1970s, in search of "an altered state of consciousness." M'Lady, accord-

ing to her own account, went so far as to film the bloody act of cutting a hole in her own head.

So, while they run studies into the "benefits" of cannabis and other "social drugs," Lady Neidpath and her foundation are really into psychedelics, particularly LSD, whose inventor Albert Hofmann was a close friend of Feilding. She told the *London Times* just this month, that the Foundation is proud to have been the first to secure permission to use LSD on human subjects in "a scientific context" in 35 years, a study being carried out "at a secret institution in the U.S."

This bears investigating.

### **Drug Legalization on Russia's Border?**

In 2000, when the U.S. Drug Enforcement Administration busted one Leonard Pickard for running one of the largest LSD operations in U.S. history (out of a decommissioned Atlas missile silo in Kansas), with enough raw material to produce 10 million or more LSD doses monthly, Lord and Lady Neidpath wrote a letter to the prosecutor requesting leniency because Pickard had helped them plan conferences on "Drugs and Society" at Queen Elizabeth II's Windsor Castle, and arranged conferences on drug policy which featured British Home Secretary Jack Straw and Drug Czar Keith Hellawell.

Yet, this brazen narco-foundation functions as a British government cutout, to which the House of Lords has opened its doors. The Foundation has held its annual Global Drug Policy Seminars in the House of Lords since 2003, attended by top government officials (e.g., the head of the Drug Strategy Directorate, Home Office) and diplomats, as well as prominent lords and ladies. Its 2003 meeting at the Royal Society was co-sponsored by the U.K. Cabinet Office Strategy Unit; and in 2005, the U.K. government's "Foresight" program co-sponsored a "Brain Science, Addiction and Drugs Project" with the Beckley Foundation, and assigned the foundation the task of developing "a long term, sustainable policy on the management of recreational drugs."

All of which raises the question: Could trepanation explain what happened to Soros's personal psychopath, Georgia's Mikheil Saakashvili? After all, in a May 2008 study, the Beckley Foundation praised Saakashvili's drug policy. Is London about to get their puppet Georgian government to legalize drugs, right on Russia's border?
